Market Rules

1. All products, which include but are not limited to vegetables, seedlings, herbs, preserves, fresh cut & dried flowers, meats, poultry, seafood, dairy products, prepared foods, crafts, etc sold at this event must be grown, raised, harvested or prepared within the town limits of Whitefield by the vendors. All vendors must be legal residents of Whitefield, Maine. Any exception to this rule must be approved by a majority of the vendors and the market coordinator no later than July 15, 2009.
2. Knowledge of and compliance with all state regulations, permits and licenses regarding the production, labeling, display and sale of all products at this event are the responsibilities of the individual vendors.
3. All vendors must provide proof of general liability insurance and all needed licenses to the market coordinator prior to selling at the market.
4. All vendors are responsible for their own area and will supply containers for their trash and will leave their site clean and in a condition suitable to its previous or normal use.
